CONCERNING YOUR LETTER DECEMBER SIX DEPORTATION ENEMY ALIENS FROM CENTRAL AMERICA CMA DESIRE YOU ARRANGE FOR DE-PORTATION TO LOS ANGELES ON VESSEL MENTIONED OF ALIENS LISTED AS AVAILABLE COSTA RICA AND GUATEMALA PD STATE DEPARTMENT IS ISSUING APPROPRIATE INSTRUCTIONS THIS CONNECTION BUT DOES NOT RPT NOT DESIRE DEPORTATION ALIENS FROM SALVADOR AT PRESENT PE ARRANGEMENTS MADE WITH DEPARTMENT OF JUSTICE TO HANDLE DEPORTED ALIENS AT DESTINATION PD STATE DEPARTMENT ALSO DESIRES IMMEDIATE DEPORTATION FROM PERU OF NINE JAPANESE TAILORS RECENTLY APPROVED FOR DEPORTATION BY PERUVIAN GOVERNMENT PD SUGGESTS BRINGING THEM TO CANAL ZONE BY AIR FOR INTERNMENT PENDING ULTIMATE SHIPMENT TO STATES PD THIS TO OPEN WAY FOR CONTEMPLATED SUBSEQUENT DE-PORTATION TO STATES FROM PERU OF AXIS NATIONALS INCLUDING ONE THOUSAND JAPANESE AND TWO HUNDRED RIFTY GERMANS PO COMPLETION THIS PLAN DEPENDENT ON AVAILABILITY NECESSARY TRANSPORTATION AND OF INTERNMENT FACILITIES IN STATES PO THESE INTERNED NATIONALS ARE TO BE USED FOR EXCHANGE WITH INTERNED AMERICAN CIVILIAN NATIONALS PD REQUEST YOUR REACTION TO PROPOSAL RELATIVE NINE JAPANESE TAILORS AND ALSO REGARDING GENERAL DESIRABILITY OF BRINGING ENEMY ALIENS FROM NEIGHBORING COUNTRIES TO CANAL ZONE

THIS DOCUMENT WILL BE SAFEGUARDE WITH THE GREATEST CARE AND WILL BE RUTURNED TO THE COMMANDING GENERAL CARIBBEAN DEFENSE COMMANDS WITHOUT DELAY.
